(15) Description of equipment

The vibration screen machine system consists of multiple superimposed screen decks at different angles. The screen surfaces of the individual screen decks are placed in vibration in a compact welded steel housing by means of motor vibrators or exciters. The vibrating housing is mounted on four spring hangers. The material to be sized is fed from above through a feed connection and it is discharged separately through four different mesh widths.

The machine is designed for feed granulated sewage sludge.
